1 APPLICATION

### Product description:

Highly effective, alkaline-based intensive cleaner for the removal of exterior organic and inorganic contaminants. Ideal for the intensive cleaning of Polymer Composite decking and all other wood-plastic composites in outdoor areas.

### Recommended use:

Osmo Polymer Composite Cleaner was especially developed to clean WPC and BPC decking and other waterproof surfaces in outdoor areas, such as garden furniture and fencing made of synthetic materials.

### Ingredients:

Alkaline cleaner (according to EC Regulation 648/2004 on detergents): <5% cationic surfactants; non-ionic surfactants; silicates; complexing agents and additives. Detailed declaration of ingredients available upon request.

### Technical Data:

Specific gravity: 1.05-1.10 g/cm<sup>3</sup>  
Viscosity: 20-25s DIN 53211/3 mm  
Odour: faint/mild, odourless after drying  
Flashpoint: not required  
pH value: 10,9

### Storage:

2 years and longer if stored in the closed original can.  
Do not expose to frost or temperatures above 30 °C!

### Surface Preparation:

Loosen and remove dirt with a firm broom/hand brush from the surface.

### Methods of Application:

Dilute concentrate with water, 1 : 10 - 1 : 20. Apply to the surface and loosen dirt with a scrub brush or a firm broom. Then rinse with clear water. Please check product compatibility with the substrate before cleaning! For the machine cleaning of decking, we recommend using Osmo Decking and Flooring Cleaning Machine.

### Cleaning of tools:

With soap and water.

### Drying time:

Approx. 24 hours (normal climatic conditions, 23 °C/50 % rel. humidity). Ventilate well while drying. Lower temperatures and/or higher air humidity may increase drying times.

### Coverage:

1 litre covers approx. 10-50 m<sup>2</sup> for one application (depending on the level of contamination).

### Note:

Do not use undiluted. May cause discolourations or surface changes when used on unknown substrates. If possible use on the entire surface. Do not allow solution to dry. Not recommended for daily cleaning.

### Caution:

Contains disodium metasilicate. Causes skin irritation. Causes serious eye damage. Reacts with acids with evolution of heat. Risk of splashing! The general safety regulations when handling chemicals must be observed. Keep out of reach of children. Read carefully and follow all instructions. Wear protective gloves/eye protection. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present



and easy to do. Continue rinsing. IF ON SKIN: Wash with plenty of water. If medical advice is needed, have product container or label at hand. Safety data sheet available on request.
